Louis W. Juhlmann Jr., age 90, passed away peacefully on February 24, 2026 at his home in Moorestown surrounded by his family.

Born in Camden, NJ to the late, Louis W. Juhlmann Sr. and Ruth Collins Juhlmann. He attended Moorestown Schools and graduated from Moorestown High School Class of 1954. Lou continued his education studying at the Philadelphia Museum College of Art and Fleisher Art Memorial.
